**LIMITED REVIEW REPORT TO VISAGAR FINANCIAL SERVICES LIMITED**

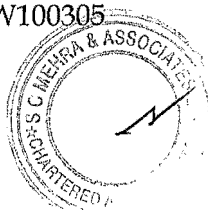
